Accommodation Agreement

I agree to the following conditions when staying at the Inverloch Surf Life Saving Club clubhouse:

- o I will sign the Clubhouse Accommodation Register when it is expected by my parents that I am staying at the club
- o I will observe all club rules
- o I will follow the directions of the Patrol Captain or other Approved Supervisor.
- o I will observe the curfew and be within club premises by:
 - SRCs - 8:00pm or Sunset (whichever is earlier)
 - Under 18 - 10:00pm
 And stay in the club premises until sunrise
- o I will inform the Patrol Captain or Approved Supervisor before leaving the club premises at times outside of curfew, or I will write the details of where I have gone and my intended time of return on the whiteboard in the kitchen (EG: Swimming, at Café)
- o I understand that I may for the purpose of participating in social activities (eg: BBQs, Movie Nights, Private Parties) stay out beyond curfew when the following criteria have been met:
 - I stay in the company of an Approved Supervisor
 - I have recorded in the details accommodation log
 - I will return by midnight
- o I will refrain from smoking, drinking alcohol or taking drugs or bringing same onto the club premises

I understand that the Patrol Captain or Approved Supervisor is a fellow club member who wishes to enjoy their time at the club also, and as such I will be considerate and act responsibly and maturely. I understand that should I wilfully breach any part of this agreement the Committee will, as a minimum, suspend my right to stay at the club for the remainder of the season.

Parent/Legal Guardian Agreement and Consent

1. I agree that supervision is provided by the club based on the assumption that my son/daughter will follow all club rules including the requirements set out in this agreement. 5. We accept that the club Approved Supervisors will accept what my son/daughter may say on face value unless proved otherwise. Should I have concerns, I understand that it is my responsibility to contact the Approved Supervisor in person to discuss my concerns
6. I have listed any restrictions or amendments to what my son/daughter is permitted to do below.
